










## **Traffic Safety Program Goal**


•Identify traffic safety problem areas and programs to reduce the number and severity of traffic-related crashes, injuries, and fatalities.

#### **Section 405h Federal Funding**

Section 405 h: Non-motorized Safety Funds

Grant funds may be used for:

a) Training law enforcement on state laws applicable to pedestrian and bicycle safety.

- b) Enforcement mobilizations and campaigns designed to enforce state laws applicable to pedestrian and bicycle safety.
- c) Public education and awareness programs designed to inform motorists, pedestrians and bicyclists of state laws applicable to pedestrian and bicycle safety.

# **Engineering Efforts**

- Safer places to walk along a roadway such as complete sidewalk networks
- Safer places to cross a roadway such as intersection improvements including pedestrian signals, detection and crosswalks
- Pedestrian Hybrid Beacons for mid-block crosswalks



# **Shared Responsibility**

- Drivers, pedestrians and bicyclists have a shared responsibility to keep themselves and others safe on the road.
  - Drivers, pedestrians and bicyclists must follow all traffic rules, signs and signals.
  - All must exercise caution, be aware of their surroundings and avoid distractions to ensure a safe arrival at their destination.
  - Pedestrians and bicyclists: never assume a driver sees you.
     Make eye contact with drivers before you cross the street or enter an intersection.
  - Remember, as a pedestrian, your eyes and ears are your best tools for staying safe when walking along roadways. Stay alert to stay safe.
