Melissa Walden provided an update on the Texas State Highway Safety Plan with regards to the Pedestrian Emphasis Area of the plan.

#### Pedestrian Analytics

- o 714 fatalities
- 1,154 suspected serious injuries in 2020
- Association with other Emphasis Areas
  - 24% intersections
  - 11% older users
  - 82% impairment
  - 13% distraction by driver
    - 65% (6,088) crashes occurred in dark lighting conditions
