September 14, 2022 Via Teams | 10:00 a.m. – 11:30 a.m.

# Welcome & Introductions

Ben Ettelman of TTI welcomed everyone to the meeting and provided instructions on participating via the Microsoft Teams chat box. Forty-nine people attended via Microsoft Teams. Attendees who provided their names in the Chat or could be identified on Teams are listed at the end of this summary. ## FY22 Annual Forum Review

Ben went on to provide a review of the 2022 Pedestrian Safety Forum that was held on August 17, 2022 in Austin, Texas at the Norris Center. This was the first in-person event in two years. A total of 232 people registered for the Forum. We had approximately 200 people in attendance from transportation agencies, including the United States Department of Transportation, Federal Highway Administration, National Highway Traffic Safety Administration, Texas Department of Transportation, as well as many Councils of Governments and Metropolitan Planning Organizations from across the state. Also in attendance were engineering firms, research institutes (TTI and CTR), law enforcement agencies, non-profit and advocacy groups, as well as public health professionals.

Feedback from Forum attendees indicated that the Forum was extremely useful and that the presentations addressed relevant pedestrian safety issues and solutions. Suggestions for presentation topics at a future Forum included more information on child pedestrian safety, air quality as it relates to pedestrians, updates on the USDOT SS4A grant applications, effective education and outreach programs, and continued updates on changes in the laws regarding pedestrians and connecting with more advocacy groups for vulnerable road users to better understand their needs.

## **Guest Presenters**

Jeff Warner, a research scientist with Texas A&M Transportation Institute, presented on pedestrian safety and rail rights-of-way. Jeff reviewed pedestrian statics around rail rights-of-way and how the Federal Railroad Administration and the Federal Transit Administration are working to improve pedestrian safety in these areas and the improvement that's been seen. He shared two recently completed Transit Cooperative Research Program (TCRP) reports:

- TCRP Report 175: Guidebook on Pedestrian Crossings of Public Transit Rail Services, and
- TCRP Report 233: <u>Strategies for Deterring Trespassing on Rail Transit and Commuter Rail Rights-of-Way</u>.

Becky Walker, regional program manager with the National Highway Traffic Safety Administration (NHTSA) shared an overview of pedestrian statistics along with resources available in the public domain for use by anyone who wishes to use and share them. ## October – Pedestrian Safety Month

Elizabeth Jones, program area manager, pedestrian/bike with the Texas Department of Transportation (TxDOT), reported on activities that will be happening as a part of Pedestrian Safety Month. Elizabeth noted that October is recognized by NHTSA as Pedestrian Safety Month. A summary of TxDOT activities for Pedestrian Safety Month includes:

- TxDOT will deploy Walking Billboards around the state again in October as our Pedestrian Safety Campaign brings awareness during Pedestrian Safety Month,
- National Walk / Bike to School Day is the 1<sup>st</sup> Wednesday in October (October 5th),
- TxDOT has limited Safe Routes to School educational items and incentives available.
