



## Statewide Pedestrian Safety Coalition FY23 Meeting #1 Notes

*December 14 – 10:00 a.m. – Meeting conducted via Microsoft Teams*

### Welcome, Introductions and Virtual Meeting Overview

Michael Manser of TTI welcomed everyone to the meeting, and thanked TxDOT for funding the grant that makes it possible to conduct these meetings and other activities that help to promote pedestrian safety in Texas. Approximately 74 people attended via Microsoft Teams. Attendees who provided their names in the Chat or could be identified on Teams are listed at the end of this summary. The complete transcript of the Teams Chat is also included at the end of this summary.

### 2023 TxDOT Transportation Alternatives Call for Projects

Noah Heath, Transportation Alternatives Program Manager at TxDOT, presented information on the Transportation Alternatives Call for Project for 2023. For more information on this and other bicycle and pedestrian funding updates, visit [TxDOT Bicycle and Pedestrian Funding Page for Updates](#).

Mike Manser asked Noah to give examples of match that can be used to achieve the 20% local match required for projects. Noah answered that the primary options for the Transportation Alternatives projects are either cash match or, for eligible projects, transportation development credits that eliminate the need for local match. For this program, there are not a lot of other federal funds that can be used for local match.

The deadline for preliminary applications is January 27, 2023. Preliminary application is very high-level, three pages; and you need to submit a preliminary application to be eligible to submit a detailed application later.

### FY23 Grant Year Overview

Mike provided an overview of the planned activities for the FY23 grant year. We are in the first quarter of the new grant year. Plans for this year include the following:

- Strategic Plan – this plan helps to ensure that project efforts and resources are targeted to the communities with the most serious pedestrian safety problems, as determined by TxDOT's crash records data. The Strategic Plan for this grant was completed in November.
- Contact Updates – throughout the year, we try to keep updating the list of pedestrian safety stakeholders involved in the Coalition.
- 2023 Forum – every year, we put on a Forum dedicated to pedestrian safety. We try to bring in speakers from around the state and the nation to speak on aspects of pedestrian safety. 2023's Forum will be in August.



- Task Force – we want to bring together a group of ped safety stakeholders to determine high-priority topics to focus on.
- Webinar Series – The first webinar scheduled for this year will focus on alcohol impairment in pedestrian-involved crashes. We are looking for topics for second and third webinars for this year.

## 2023 Pedestrian Safety Annual Forum

Ben announced Thursday, August 24, 2023 as the planned date for the Pedestrian Safety Annual Forum. This year the Forum will be held in San Antonio. A Save the Date announcement will be sent out in January.

We have a running list of topics that we've gotten from past Forum evaluations and from all of you. Some of these include metrics associated with pedestrian safety, innovative pedestrian safety approaches, pedestrian safety for children, and equity implications of transportation safety. What would you like to see presented at the Forum? A call for Forum speakers is open here: [Call for speakers](#).

Suggestions received during the meeting for Forum topics and speakers included the following:

- US vs EU differences (e.g., they walk 5 times the distance we do every day, per capita, and get killed at just 1/5th the rate (per capita). John Pucher & Ralph Buehler are best for that EU vs US topic.
- Could forum topics be workshops with attendee engagement and small groups?
- FHWA - EDC-7 mentions illumination with a reference to pedestrian lighting - so Pedestrian lighting? [https://www.fhwa.dot.gov/innovation/everydaycounts/edc\\_7/](https://www.fhwa.dot.gov/innovation/everydaycounts/edc_7/) Millie Hayes (FHWA) offered to either present on this topic or to invite some of the people who worked on the research on this topic.
- Distances walked per day per capita in US by location + backgrounds of those killed (e.g., homeless, drunk & partying, running/jogging for exercise).
- Safe System Approach has been a big topic more recently. Would be good to have a topic on the pedestrian's role in the Safe System Approach.
- Maybe satellite images of lighting levels vs pop density can give us a sense of how much better that facet is in EU vs US?
- How about moving from the traditional approach to safety, to the safe systems approach. It's important to help folks understand ways to approach this paradigm shift.

## Texas Pedestrian Safety Task Force (PTSF)

Coalition members who serve on the PTSF will review TTI-supplied data on pedestrian-involved crashes, as well as Pedestrian Safety Action Plans from priority jurisdictions. From this information, the PTSF will prioritize a list of pedestrian safety initiatives and countermeasures. TTI will use the Task Force input to create a guiding document to be shared back out to the Coalition and submitted to TxDOT.

- Collaborative development agreements to improve pedestrian infrastructure
- Ped safety law awareness, outreach, education
- Equity and ped safety
- Air quality impacts to vulnerable road users.
