### 2023 Texas Pedestrian Safety Forum Recap

- The Texas Pedestrian Safety Forum was held Thursday, August 25<sup>th</sup>, at the Norris Center in San Antonio.
  - Ben discussed the feedback provided and that the numbers of surveys were limited but if anyone had feedback to please let our team know – "we are consistently trying to make the forum better"
- Approximately 230 people registered for the forum, but on the day of, there were about 50 no shows. Ben asked the group for ideas on how to deal with no shows and get more people to show up.
  - o It was suggested "For no shows, I have found that offering a virtual or proceedings only sign up helps. Sometime people signup only wanting to be sure they get the presentations." For better evaluation participation, a small raffle for filling them out on site helps." "Offering CEU's is always a good way to increase attendance. Very good justification for the attendee to provide to their employer. Possibly law enforcement, social work, etc." (Ben: this costs money)
- Looking at a different location. We are aiming for the end of April. We plan to hold a walking and
  or accessibility audit day before the forum and an unofficial social. This would give us more
  opportunities to network.
