# **Guest Speakers**

1. Farm & City: Impacts of Policy & Developments on the Texas Hill

Jay Blazek Crossley, Executive Director, Farm & City

Jay Blazek Crossley, the Executive Director of Farm & City, a non-profit organization dedicated to promoting sustainable transportation and equitable urban planning in Texas, delivered an insightful presentation focused on legislative efforts to improve pedestrian safety. Farm & City's mission is to enhance public understanding of proposed bills aimed at creating safer streets, and Jay's discussion centered on several key pieces of legislation that

are currently shaping the landscape of pedestrian safety during the ongoing legislative session.

With only 68 days remaining in the session, Jay outlined several significant bills under consideration, including those addressing Safe Neighborhood Street design, local street railroad crossings, and the establishment of safe driveways in accordance with the Lisa Torry Smith Act. He emphasized the importance of recognizing sidewalk users as a distinct class of road users and discussed the implications of the Safe Passing Law, which aims to protect pedestrians and cyclists. Additionally, Jay highlighted bills that would improve motorist behavior, such as the "Move Over or Slow Down" law for public servants and stranded motorists.

Jay also touched on critical infrastructure and safety initiatives, including the Fix Our Highway Injury Network Map, which seeks to identify the most dangerous roadway segments in need of improvement. He advocated for a consistent hands-free law, accountability for reckless, distracted, and speeding drivers bill, and increased sidewalk funding. Other notable bills included those aimed at enhancing school bus safety with cameras and promoting Texas-themed crosswalks.

Throughout his presentation, Jay provided a detailed analysis of each bill's relevance, potential impact, and likelihood of garnering legislative support. He encouraged thoughtful consideration of these proposals and underscored their collective potential to elevate pedestrian safety as a priority in Texas.

To further support the conversation, Jay shared additional resources, including the Farm & City agenda, which offers more in-depth information on key bills. He welcomed feedback from the audience and concluded the session with a brief Q&A, engaging participants in a constructive discussion on the path forward for pedestrian safety legislation in the state. Gina Torry follows up on the Q&A by highlighting the importance of the Lisa Tory Smith Act and expressing gratitude toward Jay for his pivotal role in ensuring its passage. She emphasizes the need for heightened awareness of pedestrian safety laws. Regarding the Bus Driver Camera Act, she addresses the pressure bus drivers often face to maintain tight schedules, leading to dangerous behaviors such as speeding through school zones. Gina shares an account of an incident where a student narrowly avoided being hit by a reckless driver. She concludes by expressing strong support for the approval of the Bus Camera Act, recognizing its potential to enhance safety.

### 1. Enhancing Pedestrian Safety with Traffic Gardens

Ellen Walston Injury Prevention Program Coordinator, Eastern Carolina Injury Prevention Program at ECU Health Medical Center

Ellen Walston, a public health advocate and safety educator, coordinates injury prevention

initiatives in North Carolina. Her work focuses on innovative, community-based approaches to traffic safety, such as traffic gardens, quick builds, and other creative strategies designed to engage and protect pedestrians of all ages.

One of the key initiatives she discussed was the Traffic Garden, a concept that allows youth to build, demonstrate, and role-play in a designated space. This initiative is aimed at teaching younger generations about traffic laws and rules, offering them an opportunity to better understand traffic safety while fostering future improvements in road conditions. Ellen provided an in-depth overview of the concept, its benefits, and its implementation in North Carolina. She also explained why this concept holds great potential for improving traffic safety in Texas.

Ellen credited Marry Jo Gellenbeck with starting the conversation around traffic gardens and inspiring her to introduce the concept in North Carolina. Through this, Ellen emphasized the importance of enhancing protections for vulnerable road users. She also shared valuable resources, such as Traffic Gardens.com, where individuals can access free materials and tools to implement traffic safety gardens, as well as insights from Marry Jo Gellenbeck and Fionnula Quinn to aid in outreach and communication efforts.

The Winterville community in North Carolina actively implemented the traffic garden, and Ellen walked the audience through the process, discussing the steps taken and the associated costs. A discussion followed, during which questions were raised about how data is collected for traffic gardens. While evaluation methods vary due to the organic nature of the concept, Ellen emphasized the growing recognition of its value in promoting traffic safety and engaging local communities.

Through her presentation, Ellen encouraged greater efforts to protect vulnerable road users and underscored the potential of traffic gardens to make a meaningful impact on road safety.

Gina Torry provided an update for the upcoming Fort Bend County Citizens for Road Safety Forum, which will be supported by a grant from TxDOT. The forum is scheduled to take place on September 19th in Fort Bend County.
